

Houghton County Land Bank Authority 2015 Annual Report

The Houghton County Land Bank Authority (LBA) Board of Directors met four times in 2015: May 4; July 7; August 24; and, October 26.

The board welcomed new member Tom Tikkanen and thanked outgoing member William Hodges for his service. Directors Haeussler and Tikkanen were appointed by the Houghton County commissioners to three-year terms expiring December 31, 2017. The board elected Director Haeussler and Director Hainault to serve as secretary and treasurer, respectively.

Entering 2015 the LBA had sixteen (16) properties in its inventory. The LBA sold two (2) properties via the side lot disposition program: 31-010-503-017-00 (Dodgeville) for \$200.00, and 31-043-132-008-00 (Lake Linden) for \$100.00. (Table 1, Properties 1-3.) Parcel 31-042-117-001-00 (Copper City) was sold at the first public tax sale auction for \$1,000.00. (Table 1, Property 3.)

Parcel 31-044-103-108-50 (227 Hecla Street, Laurium) was conveyed to the LBA by Wells Fargo and Company in 2015 and was sold at the first public tax sale auction for \$4,476.19. (Table 1, Property 4.)

The Houghton County treasurer foreclosed thirty-one (31) properties in 2015. The board discussed all of the tax-foreclosed properties and the vast majority of them were visited by one or more board members for visual inspection.

Prior to the first public tax sale auction the LBA expressed interest in obtaining five (5) properties to be transferred via the side lot disposition program. At the request of the LBA the county commissioners approved the county's purchase of: 31-002-108-011-00 (55877 Houghton Street, Laurium) for \$1,300.00; 31-002-170-037-00 (Lot 37 Assessor's Plat of Kearsarge) for \$650.00; 31-008-203-018-00 (23827 Hulkonen Road, Nisula) for \$1,200.00; 31-010-109-002-00 (Tapiola Road, Portage Township) for \$750.00; and, 31-014-267-057-00 (Harley Davidson Road, Torch Lake Township) for \$800.00, from the county treasurer and the sale of said properties by county to the LBA for \$4,700.00 in total. (Table 1, Properties 5-9.) The LBA subsequently sold these properties to county residents for the purchase prices plus 10% via the side lot disposition program.

Following the second and final public tax sale auction nine (9) unsold properties were rejected by their local units of government and subsequently were conveyed to the LBA by the Houghton County Treasurer. (Table 1, Properties 10-18.) A parcel adjacent to one of these properties was identified as a strategic acquisition for the purpose of future sale, thus the LBA purchased 31-041-420-136 (Fourth Street, Calumet) for \$1,000.00. (Table 1, Property 19.)

At the close of 2015 the LBA had twenty-three (23) properties in its inventory. (Table 2.)

Revised LBA policies and procedures were adopted by the board on October 26, 2015.
