

## Houghton County Land Bank Authority 2016 Annual Report

Board of Directors: Kathleen Beattie, Chairperson; John Haeussler, Secretary; James Hainault, Treasurer; Glenn Anderson; Tom Tikkanen.

The Houghton County Land Bank Authority (LBA) Board of Directors met one time in 2016: October 17.

The board elected to retain the 2015 officers with Director Haeussler serving as secretary and Director Hainault serving as treasurer.

Entering 2016 the LBA had twenty-three (23) properties in its inventory. Parcel 31-010-503-013-00, Dodgeville, was sold via side lot disposition for \$100.00. Parcels 31-041-106-008-50, 31-041-106-009-00, 31-041-420-136-00, and 31-041-420-137-00, Calumet, were sold for \$100.00 for the purpose of rehabilitation. (Table 1, Properties 1-5.)

The Houghton County treasurer foreclosed thirty-six (36) properties in 2016. The board discussed many of the tax-foreclosed properties and the majority of them were visited by one or more board members for visual inspection.

Prior to the first public tax sale auction the LBA expressed interest in obtaining six (6) properties to be transferred via side lot disposition. At the request of the LBA the county commissioners approved the county's purchase of parcels 31-001-200-084-00, 31-002-007-174-00, 31-005-177-018-00, 31-014-329-024-00, 31-044-131-001-25, and 31-044-131-001-50 from the country treasurer and the sale of said properties by the county to the LBA. The LBA subsequently sold each of these properties via side lot disposition to county residents for the purchase price plus ten percent (10%). (Table 1, Properties 6-11.)

Following the second and final public tax sale auction six (6) unsold properties were rejected by their local units of government and subsequently were conveyed to the LBA by the Houghton County Treasurer. (Table 1, Properties 12-17.)

At the close of 2016 the LBA had twenty-four (24) properties in its inventory. (Table 2.)
