Call to Order:

The meeting was called to order by Chairman Albert Koskela at 5:00 p.m.

Pledge of Allegiance:

Approval of Minutes:

A Motion was made by Commissioner Anderson and seconded by Commissioner Tikkanen to approve the minutes of the July Board of Commissioners meeting as presented.

The Motion carried by a voice vote. Ayes 5, Nays 0.

Approval of Agenda/Additions:

Chairman Koskela requested #6 be added for the Transfer Station. Commissioner Tikkanen requested #7 be added for a Resolution for the Michigan Works UP Board, and #8 be added for a Houghton County Land Bank Request.

County Officers:

Dennis Hext, Airport Manager, updated the Board on the Airport.

Paul Putnam, MSU Extension, discussed the handouts he provided to the Board.

Old Business:

1. Houghton County Jail

Commissioner Janssen stated she had contacted EGLE, and there would be a \$100 application fee, with an additional charge of \$400-\$500. She stated they would investigate the wetlands, and determine where the building should be built.

Commissioner Britz stated that him and Commissioner Janssen will schedule another meeting with Mr. Mattson.

New Business:

1. Kate Beer – Western UP Health Department

Kate Beer addressed the Board regarding the five (5) counties allocation of \$555,000. She stated the MERS funding has hurt them financially. She requested a minimum base for each county to consider of \$25,000.00.

Chairman Koskela stated there will be a Budget meeting in the future, and no action could be taken at this time.

2. Appropriation Request - KEDA

Jeff Ratcliffe, KEDA Directors, addressed the Board regarding a public health campaign, and requested \$2,000.00.

Chairman Koskela stated there will be a Budget meeting in the future, and no action could be taken at this time.

3. Tom Ressler – Meeting broadcast options

Tom Ressler, IT with Houghton County, addressed the Board and explained options for broadcasting board meetings.

The Board had discussion and decided to continue with Zoom meetings and look into other options in 2021-2022.

4. September budget meeting

The Board discussed the September budget meeting. They agreed to have it on September 29, 2020 at 5:00 p.m. A notice will go into the Gazette for the public hearing.

6. Transfer Station

Chairman Koskela stated he had been contacted by local roofers having to wait until Saturday to go to the Transfer Station, and would like the Transfer Station to be open 1 evening during the week until 7:00 pm.

The Board had discussion and agreed to refer this to the Solid Waste Committee. Commissioner Tikkanen is to schedule a Special Solid Waste Committee meeting. Commissioner Tikkanen scheduled it for August 12, 2020 at 11:00 am.

Eric Forsberg, Administrator, discussed staffing shortages at the Transfer Station, and possible closure on Saturdays.

Commissioner Tikkanen stated the Transfer Station is the busiest facility in Houghton County.

Commissioner Britz stated it would be injustice to Houghton County residents to close the Transfer Station down on Saturdays.

7. Resolution for Michigan Works UP Board

Commissioner Tikkanen discussed the facility and space program in KI Sawyer, Marquette, MI and the potential for 500-1,000 jobs.

A Motion was made by Commissioner Anderson and seconded by Commissioner Britz to approve Resolution for the Michigan Launch Initiative.

RESOLUTION REGARDING MICHIGAN LAUNCH INITIATIVE RESOLUTION #20-13

WHEREAS, Michigan Aerospace Manufacturers Association has organized the Michigan Launch Initiative (MLI) for establishing spaceport operations and command center facilities within the State of Michigan; and

WHEREAS multiple aerospace companies have plans to launch thousands of satellites into low Earth orbit (LEO); and

WHEREAS, the MLI will provide a collaborative platform for academia, industry, and governmental agencies to provide LEO and hypersonic launch technology for commercial and defense applications, with a priority to establish and launch a satellite launch facility and command center in Northern Michigan; and

WHEREAS the economic impact on the area is estimated to be \$8 million annually with an estimated job creation between 500 -1,000; and

WHEREAS Marquette County, with its minimal population density, favorable launch trajectories, and access to water is uniquely positioned for the site requirements to allow for a polar orbit satellite launch facility, low-density population, extensive restricted airspace, Interstate highway system accessible, engineering and manufacturing capacity; and

WHEREAS Chippewa County is uniquely positioned for the planned autonomous vehicle proving grounds.

NOW THEREFORE BE IT RESOLVED, the Houghton County Board of Commissioners does hereby fully support the Michigan Launch Initiative, to move forward with all required next steps, including necessary licensing, permitting, fundraising and other legal and monetary requirements to bring the project to full fruition.
