HOUGHTON COUNTY BOARD OF COMMISSIONERS ORGANIZATIONAL/REGULAR MEETING JANUARY 13, 2015

The Houghton County Board of Commissioners held an Organizational/Regular Meeting on Tuesday, January 13, 2015 at 5:00 p.m. in the 5th Floor Conference Room of the Courthouse, City of Houghton.

The meeting was opened by the County Clerk, Jennifer Lorenz.

After the Pledge of Allegiance, the following commissioners responded to roll call: Eugene Londo, District 1; Albert Koskela, District 2; Anton Pintar, District 3; Scott Ala, District 4; and Timothy Palosaari, District 5.

The first order of business was to elect a Chairman. Commissioner Palosaari made a motion to nominate Commissioner Koskela and Commissioner Londo seconded the motion. The clerk called for any other nominations. There were none. A voice vote was called on the nomination. Ayes 5, Nays 0. Commissioner Koskela was elected Chairman. The meeting was then turned over to the Chairman, Commissioner Koskela.

The Chairman announced the next order of business was to elect a Vice-Chairman. Commissioner Londo nominated Commissioner Palosaari and Commissioner Koskela seconded the motion. The Chairman called for any other nominations. There being none, the Chairman asked for one unanimous vote for Commissioner Palosaari. A voice vote was called on the nomination. Ayes 5, Nays 0.
